#### Report on the activities of the Institute of European Law

#### 2024

#### Introduction

The Institute of European Law was founded in 1990 and works on the basis of a statute approved by the Faculty Board of the Law Faculty (SU) on 22 January 1990 and by the Vice Chancellor of Stockholm University on 15 February 1990. The statute has thereafter been amended according to decisions by the Vice Chancellor, most recently on 20 May 2021. According to the Statute, the Institute's objective is to promote research and education in European Law in general, and in European Union Law, in particular. According to Article 3 of the Statute, the Institute shall fulfill its objectives by:

- developing and maintaining a specialized library;
- initiating, leading and coordinating research projects;
- gathering and processing research documentation and material;
- organizing lectures, seminars, symposia and similar qualified educational activities;
- participating in various activities of Stockholm University that are within the Institute's sphere of interest;
- cooperating with other research institutes with similar objectives.

The Institute shall strive to cooperate with educational institutions, associations, organizations and public authorities active in the Institute's field of activity.

#### Institute's Board

Gloria Golmohammadi works on her two-year post-doc project "The right to participate in the democratic life of the Union in the national context", funded by Institutet för rättsvetenskaplig forskning (Knut & Alice Wallenberg foundation).

#### **Educational activities**

The one-year **master program in European Economic Law** continues to attract a stable number of international applications, which allows forming each year a group of 25-30 well-qualified students from different countries and diverse background. The structure of the program is by now settled with a Fall Term comprising an introductory course on EU Economic Law from a Constitutional Perspective (15 ECTS), followed by a choice between three elective courses (EU Competition Law, EU Banking and Financial Law and Internal Market Law and its Social and Digital Dimension, 15 ECTS each). In the Spring Term, students take the course EU Legal Methods in Research and Practice (15 ECTS) and the program ends with a Master Thesis in EU Economic Law (15 ECTS). In the academic year 2023/2024 a class of 29 students graduated from the LLM program. In the academic year 2024/2025, the program is held with a group of 33 students. Program directors are Antonina Bakardjieva Engelbrekt and Jaan Paju.

Several **elective courses** in EU law are currently offered to students from the Swedish law program and Erasmus students. The elective courses of the master program are also offered as elective courses

to Swedish students, trying to create synergies and cost-efficient solutions. The list of courses is the following:

#### Spring Term B period

- EU External Trade Relations Law (Course Director: Claes Granmar, 15 ECTS)
- Praktisk europaprocess (Course Director: Claes Granmar, 15 ECTS)

#### Fall Term B period:

- EU Competition Law (Course Director: Björn Lundqvist, 15 ECTS)
- EU Banking and Financial Law (Course Director: Sideek Seyad Mohammed, 15 ECTS)
- The Internal Market and Its Digital and Social Dimension (Course Director: Jaan Paju, 15 ECTS)

Claes is also responsible for the pan-Nordic moot court in human rights which has been connected to the course Praktisk europaprocess. The pan-Nordic moot court in human rights is administrated from Stockholm University.

The **undergraduate course in EU law** (7.5 ECTS) is given as before during the first term of the law education. Course Director during the Spring Term of 2024 has been Björn Lundqvist and during the Fall Term of 2024 - Antonina Bakardjieva Engelbrekt.

#### Seminars and other events

In recent years the Institute has received financial support from the Cassel foundation for the seminar series in EU law. A total of 10 seminars were held throughout 2024 on a variety of topics - from fundamental rights and EU constitutional law to Internal Market, consumer and competition law. The seminars were given in various formats: in person, hybrid form or online via Zoom. The seminars have been generally well-attended. A list of the seminars is attached. In addition, an internal "brown bag lunch" seminar series was started from the Fall Term 2024 discussing ongoing research projects, drafts and ideas. The seminar series is coordinated by Claes Granmar. So far, the following seminars were given: Gloria Golmohammadi introduced her post-doc. project on the 16th of September; Björn Lundqvist presented his new project on the 7th of November; Claes Granmar organised a BBL on the European Health Data Space where the doctoral candidate Zhicheng on the 21th of November.

#### Library

#### Books:

In 2023, the Institute received a generous donation of books from the estate of the late professor Ulf Bernitz. These books have now been included in the EU library and in the digital catalogue, while certain official reports mainly from the EU Institutions had to be removed due to lack of shelf space. They were transferred to the new EU center in Bergen.

According to the Law Department's policy, all specialized libraries used to receive an annual sum of 40.000,00 SEK for books and library maintenance. This funding has been reduced in 2023 and 2024. In 2024 only a few titles were purchased.

## The DMA: A Drama in Three Acts den 12 december 2024, kl. 12:00 till 13:30

EU-domstolen har förändrats. Personaldomstolen har avskaffats och tribunalen har fått dubbelt antal ledamöter. Prövningstillstånd har införts för vissa överklaganden från tribunalen till domstolen. I år kommer kravet på prövningstillstånd utvidgas och tribunalen ska ta över ansvaret för förhandsavgöranden i vissa sakfrågor, bland annat mervärdesskattefrågor.

The EU Court of Justice has undergone changes. The Civil Service Tribunal has been abolished, and the General Court has doubled its number of judges. Leave to appeal has been introduced for certain appeals from the General Court to the Court of Justice. This year, the requirement for leave to appeal will be expanded, and the General Court will take over responsibility for preliminary rulings in certain matters, including VAT issues.

#### EU law and private norm making after Super League, in and beyond sports Seminar with professor Johan Lindholm from Umeå University den 6 mars 2024, kl. 12:00 till 13:30

At the end of 2023, the Court of Justice of the European Union issued three sports-related judgments: European Super League, International Skating Union, and Royal Antwerp. In these judgments, the Court expands on the requirements that sport governing bodies and other private actors that "collectively regulate" markets (e.g. trade unions and professional organisations) must respect under EU internal market law. This carries generell, long-term, and potentially far-reaching consequences for private norm making, far beyond the specific issue of so-called breakaway leagues in European footboll.

The re-orientation of platform regulation: Treading water or experimenting?

Yane Svetiev, Professor at University of Sydney Law School will present his draft competition law paper.

The paper analyses the re-orientation of digital platform regulation, including legislative proposals and enforcement efforts to deal with platform power in those jurisdictions. It argues that the initiatives to control platform power in these jurisdictions follow a common emergent template of measures, also followed in the EU and other key players, focused on identifying conduct violations for specifically designated platforms on the basis of structural criteria of size and concentration.

### COMPETITION LAW 2024 den 19 januari 2024, kl. 09:30 till 18:00

Several speakers. The conference aims both to deepen and broaden the attendees' knowledge in European and Swedish competition law, while also updating the attendees' substantive and methodological skills. The focus is on the current state of EU competition law and the conference places great importance on the current case law of the Union Courts and the European Commission. But also case law from Sweden is discussed extensively.
